

What is considered Financial Aid?

Any type of assistance used to assist with the Cost of Education is considered Financial Aid. (i.e. grants, loans, scholarships, waivers, vouchers, work-study jobs, etc...)



How do I apply for all types of aid?

- A student must complete the Free Application for Federal Student Aid. You may complete the FAFSA electronically at www.fafsa.ed.gov.
- Once you complete and SUBMIT your application electronically, you will receive a Student Aid Report within two weeks.
- Each school you listed on the FAFSA will also receive your information electronically and will then be in contact with you.



What is an EFC?

EFC - Estimated Family Contribution is a number determined by the U.S. Department of Education (based on your FAFSA information) that is subtracted from your Cost of Attendance to determine eligibility for Pell Grants and other need-based aid.



Deferred Payment Arrangements

Who needs A Payment Plan?

If a student's financial Aid does not cover 100% of his/her tuition and fees by the 12th class day, the student will need to make arrangements to set up a Payment Plan. A student who has not completed required financial aid paperwork is considered as a cash paying student and must adhere to the Payment Plan setup.

Deferred Payment Plan Tips to Prevent Delinquency



- Agree to pay Jarvis Christian College the total amount due per Payment Plan Agreement
 Make your Payments on time

Delinquent Deferred Payment Plan



- You can be denied access to all classes, dining hall services, and dormitory accommodations.
 You can be Administratively withdrawn from your classes.
- You will **not** be allowed to **register** any semester thereafter until balance is paid in full.
 - After 90 day delinquency, your account will be referred to a collection agency for non –payment.
 (you will be accessed any additional cost incurred, including collection fees.



What is a Cash Basis Student?



A Cash Basis Student is a student that pays total cost for all educational expenses excluding any Federal Financial Aid.

I have a credit balance on my account what does this mean?

A student is due a refund if a credit balance exists on his account after posting of all correct charges, payments, financial aid, scholarships, etc. The refund must be processed and a check issued within 14 days after the credit balance first appeared on the student's account.
